Entries must be made online by the county agent for 4-H entries or by the agricultural education teacher for FFA entries by December 5, 2023. An entry form must be printed from the online entry site to be signed by the parent, agent/teacher and the exhibitor and sent with correct entry fee(s). Copies of the entries and the correct fees must be postmarked by December 13, 2023 for the entry to be complete. All entries from a county or chapter must be mailed together with one check or money order for all of the entries from that county or chapter. No individual checks will be accepted. NO EXCEPTIONS. Entry fees are \$30 per ewe for the first 3 ewes and \$35 per ewe for the 4th and 5th ewe. EXHIBITORS CAN ENTER UP TO FIVE (5) EWES BUT WILL ONLY BE ABLE TO SHOW THREE (3) EWES.
