All heifers must be in the possession of the exhibitor on or before November 15, 2024. Entries must be made online by the county agent for 4-H entries or by the agricultural education teacher for FFA entries by November 15, 2024. An exhibitor may enter up to five (5) heifers but the can only show up to three (3) at the state show. An entry form may be printed from the online entry site to be signed by the parent, agent/teacher and the exhibitor and sent with correct entry fee(s) or this entry form (signed by the parent, agent/teacher and exhibitor) may be mailed with the correct entry fee(s). Copies of the entries and the correct fees must be postmarked by November 22, 2024 for the entry to be complete. Entry fees are \$30 per heifer.

All entries from a county or chapter must be mailed together with one check or money order for all of the entries from that county or chapter. No individual checks will be accepted. \$30 entry fee per heifer must accompany the signed form. Make check payable to Georgia Junior Livestock Shows (DO NOT SEND CASH) and mail by November 22, 2024 to: Georgia Junior Livestock Shows, Edgar Rhodes Center, 425 River Rd., Athens, GA 30602-2771. Entry fees are not refundable.
