All heifers must be owned by the exhibitor on or before November 1, 2024. Entries must be made online by the county agent for 4-H entries or by the agricultural education teacher for FFA entries by November 1, 2024. An exhibitor may enter and show only 4 beef heifers (registered and commercial) at the State Show. An entry form must be printed from the online entry site to be signed by the parent, agent/teacher and the exhibitor and sent with correct entry fee(s). Copies of the entries and the correct fees must be postmarked by November 8, 2024 for the entry to be complete. Entry fees are \$30 per heifer.

All entries from a county or chapter must be mailed together with one check or money order for all of the entries from that county or chapter. No individual checks will be accepted. No exceptions. \$30 entry fee per heifer must accompany the signed form.
