All market beef animals must be owned by the exhibitor on or before November 1, 2024. **Entries must be made online** by the county agent for 4-H entries or by the agricultural education teacher for FFA entries by November 1, 2024. An entry form must be printed from the online entry site to be signed by the parent, agent/teacher and the exhibitor and sent with correct entry fee(s). Copies of the entries and the correct fees must be postmarked by November 8, 2024 for the entry to be complete. Entry fees are **\$30 per market steer and market heifer.**

All entries from a county or chapter must be mailed together with one check or money order for all of the entries from that county or chapter. No individual checks will be accepted. No exceptions. Make check payable to Georgia Junior Livestock Shows. **(DO NOT SEND CASH)** and mail by November 8, 2024 to: Georgia Junior Livestock Shows, Edgar Rhodes Center, 425 River Rd., Athens, GA 30602-2771. **Entry fees are not refundable.**
