

# **Rules and Regulations**

- Exhibitors in this show must be a member of 4-H or FFA at time of entry.
- All livestock being exhibited must have an official certificate of veterinary inspection (health certificate). This certificate of veterinary inspection must be issued within 30 days of the exhibition. See the current year Georgia 4-H and FFA State Livestock Shows Rules and Regulations for specific information for 4-H and FFA health certificates. No animals will be allowed entry to the show without the proper health records and test requirements.
- Exhibitors must be actively participating in a livestock project and must be the owner of their animals.
- An exhibitor may enter an unlimited number of animals to show, but may not have more than two entries in any one class in competition for prize money.
- Each exhibitor must furnish their own animals' feed, feed pan, water pail and show supplies.
- It is the responsibility of each exhibitor to feed, water, clean-up after and provide general care of their animals while on property.
- Veterinarian service for animals while on property is at the owner's expense.
- Neither the AgGeorgia Farm Credit, Northwest Georgia Research & Education Livestock Pavilion, University of Georgia, Gordon County Extension/4-H, Gordon County, Georgia, nor any of its employees are responsible for loss or damage to any animal and/or personal property of exhibitor.
- We shall honor the Statement of Relation (Memorandum of Understanding) between Vocational Education and the Cooperative Extension which is considered the official agreement. This agreement guides 4-H and FFA participation in events. The intent of the agreement is to support youth participating in both organizations with different project areas and to disallow a young person competing in both organizations with the same project area in the same year.
- There will be no access to the livestock pavilion or pen area, with the exception of limited access to restrooms. All animals will be required to show off the trailer; NO PENS AVAILABLE. Wash area will be available outside the pavilion, but no access to the wash racks is allowed. No power available on site; generators are allowed.

- Entry form must be postmarked no later than Friday, December 11, 2020 and received no later than December 16, 2020. No late entries will be accepted this year due to COVID-19 restrictions.
- Entry form is not to be faxed or emailed ; payment must accompany entry.
- Entry fees are non-refundable, except in the event of show cancellation. If the show is cancelled, refunds will be made to all exhibitors.
- Mail completed entry form with payment to Gordon County 4-H AgGeorgia Weekend Spectacular 1282 Highway 53 Spur, SW - Suite 200 Calhoun, Georgia 30701.
- The show will be held **OUTSIDE** the Northwest Georgia Research and Education Livestock Pavilion under a tent at 1286 Highway 53 Spur SW, Calhoun, GA.
- The show committee reserves the right to disqualify any animal on the basis of health concerns.
- Due to it being the Holiday Season, all premiums will be paid by mailed check from Gordon County Extension/4-H **after January 1, 2021.**

#### Showmanship Classes:

All showmanship classes will be based on current grade in school. Showmanship will start with 12th grade and go down. The exhibitor may show any one of his/her entries in the showmanship contest; however, any animal which is removed for any reason from the show cannot be shown in showmanship.

### Market/Breed Classes:

Entries will be divided by weight into as equal classes as possible. Barrows and gilts will be shown separately by weight. Commercial breeding ewes, breeding does, and steers will be shown by weight; whereas, registered ewes and does and all heifers will be shown by age. Class sizes are at the discretion of the show committee.



## **Special Rules and Regulations Due to COVID-19**

### **PLEASE READ IN ENTIRETY**

- The show will be held <u>OUTSIDE</u> of the pavilion in a grassy area under a tent with no seating provided. There will be no access to the interior of the pavilion or pen area except for the restroom area.
- <u>All animals will be required to show off the trailer; NO PENS AVAILABLE.</u>
  <u>Wash area will be available outside the pavilion, but no access to the wash</u>
  <u>racks is allowed. No power available on site; generators are allowed.</u>
- If a registered exhibitor has a positive COVID-19 test, experiences COVID-19 symptoms, or is in quarantine after a direct contact with someone with COVID-19, the exhibitor and their immediate family <u>SHOULD NOT</u> come to the show. You may contact Tim Street at 706-629 -8685 to request a refund or name a substitute showman for your animals. The substitute showman can be anyone registered as an exhibitor in the show, but needs to be identified prior to show time.
- We will follow UGA and Georgia 4-H COVID-19 related policies at that time, but current policy requires that all participants undergo a COVID-19 screening questionnaire from staff, and all spectators will be asked to self-screen.
- All youth and adults will be <u>**REQUIRED**</u> to wear masks at all times inside during restroom visits and anytime where 6 foot social distancing cannot be maintained outside. You can bring your own mask or one will be provided for you.
- Hand sanitizer stations will be available throughout the show area.
- If you or anyone in your party has experienced symptoms, been diagnosed with, or suspected to have COVID-19 within 14 days prior to the show, STAY HOME!
- If you experience symptoms of COVID-19 during the event, you will be isolated and asked to leave.
- Food and drinks will be on your own. Feel free to bring your own meals and snacks; 4-H will not be providing any food or drink items through a concession stand this year. **No** cooking on site and no shared meals.
