*Apple Capital Market Hog Show*

1. Show will be held Gilmer County Agriculture Education Center located at 1020 Clear Creek Road in Ellijay, Georgia 30536.
2. The Show is open to current 4-H and FFA members only.
3. All Georgia 4-H and FFA State Livestock Rules and Regulations will be followed.
4. Only Market Gilts or Barrows Allowed. **NO BREEDING GILTS**. All animals will be shown as commercial market animals.
5. An exhibitor can bring up to 3 hogs and no more than 3.
6. **Weigh-In:** After the Hog leaves the scales there will be no additional weigh in without show official consent.  
Weigh in will be Saturday, February 8<sup>th</sup> from 7:00 a.m. to 9:00 a.m.
7. Hogs will be weighed and divided into classes of eight to twelve (8-12) Hogs per class as equal in number as possible. (Number of classes may vary depending on the number of entries and the show official's discretion).
8. **Classes:** Exhibitors must show their own hog in class. If the exhibitor has more than one hog in a class, they can have another exhibitor show for them. This must be cleared with show officials before showing.
9. The show will be split into a gilt show and barrow show as long as there are enough animals registered.
10. All Hogs must be ear tagged with state identification tags.
11. **Showmanship:** Each exhibitor must show their own animal in showmanship. The animal must be entered in the show and owned by the exhibitor. (Showmanship will begin at 9:30 a.m.) There is a \$5.00 fee for showmanship participation.
12. Pens will be assigned to counties (The show committee reserves the right to ask you to house your animal on your trailer if we run out of pen space.) Pen Alterations are not allowed. You may be asked to pen pig two to a pen. Bedding will be provided, but if any extra is needed it will be the responsibility of the exhibitor.
13. All market swine must be blood tested **PRV and Brucellosis negative** and have an official health certificate. Any visibly sick animal will be asked to leave the premises.
14. All hogs must have a premise ID tag and State Show tag.
15. **Entry Fee:** The entry fee per animal is \$20. Late entries fee will be charged an additional \$20.00 per exhibitor. Money will be used for prize money after show expenses are removed. Amount of prize money is based on entries and is subject to change\*:  
Payouts will be for the following:  
Top 5 Gilts and Top 5 Barrows  
Top 5 Individuals in Classes (market classes and showmanship)  
Buckles will be awarded for Showmanship Champions in a Junior and Senior Division
16. The Gilmer County FFA reserves the right to review the rule and make changes if necessary. All decisions made by the Gilmer County FFA are final.
17. No alcoholic beverages or weapons on school premises are allowed any violators will be asked to leave immediately.
18. The Apple Capital Market Hog Show Committee, Gilmer FFA, or any associated agency or any of its affiliates do not accept responsibility nor assume any risks for injury to the exhibitor or animal due to or resulting from participation in the Apple Capital Market Hog Show.

\*Show officials have the right to reduce price payout based on entries received without notice.
