### Rules and Regulations for The Coffee County Swine Showdown

- 1. Exhibitors from all states will be eligible to show.
- 2. Any exhibitor ages 4 through 21 **will** be allowed to enter the show. Pre-club exhibitors must be able to exhibit his/her hog **without** the assistance of an adult or older exhibitor in the ring.
- 3. There is **NO** limit to the number of entries per exhibitor, but only one showmanship entry will be allowed per exhibitor.
- 4. Pigs housed in the barn will be penned <u>2 pigs per a pen</u>. Pens are 5' X 5'. Bring a divider if you need one. There will be limited penning available in the barn approximately 120 head, but you may show off your trailer. Pens will be assigned on first-come, first-served basis as entry forms are mailed in.
- 5. All entries must be accompanied by current health papers at the time of check-in.
- 6. All hogs must be tagged, and tag numbers must be included on the entry form. Each tag must be clean and readable at the time of check-in. State-issued tags are not necessary. RFID tag numbers will also be accepted. **Absolutely no hogs will be accepted without a tag.**
- 8. All Market Hogs (barrows and gilts) will be shown by **weight**. There is **NO** weight limit on Market Hogs. Barrows and gilts will be shown separately numbers permitting.
- 9. Classes will be split based on weight. Hogs will be shown lightest to heaviest.

#### PUREBRED MARKET HOG SHOW

- 1. Four (4) purebred market hog breeds will be recognized at the 2020 Coffee County Swine Showdown: Duroc, Hampshire, Landrace, Yorkshire.
- 2. A minimum of ten (10) purebred market hogs per sex will be required to constitute a class of purebreds. If the minimum is not met, those market barrows or market gilts will show in the crossbred classes.
- 3. The original registration certificate must be presented at the time market hogs are checked in to the show. No copies or duplication of the original registration certificate will be accepted. Registration certificate must be made out in the exhibitor's name only. Farm names will not be acceptable.
- 4. All purebred market barrows will be exhibited in one (1) class. All purebred market gilts will be exhibited in one (1) class. The Purebred Champion and Purebred Reserve will compete in the Final Drive for Top 4 Market Barrow (Gilt).

- 10. Show management reserves the right to change, combine or delete classes with insufficient entries.
- 11. Show officials reserve the right to interpret all rules, and their decisions will be final. After pigs have been weighed and leave the scales, **there will be no changes made**. Any changes that need to be made must be made before leaving check-in. Show officials also reserve the right to reject any entries for whatever reasons necessary. **Decisions made by show officials will be final.**
- 12. The judge's decision is **final** in all classes.
- 13. Clipping animals on the premises will **not** be allowed.
- 14. Only show officials and exhibitors are allowed in the show ring.
- 15. This is a cash jackpot.
- 16. Exhibitors are responsible for his or her own animal and must assume all associated risk.
- 17. **Coffee County BOE and Coffee Middle School** nor anyone or anybody associated with the show are liable for accidents, injuries, or theft.
- 18. Bedding will **NOT** be provided you must bring your own bedding (wood shavings). Straw is **NOT** allowed.
