Official Rules and Regulations

Entry Requirements for Show

1. Barrows and gilts will be shown separately.
There will be a Grand Champion and Reserve Grand Champion for each sex.
2. Show day will be Saturday, January 5, 2019 at 11:00.
Hogs will be weighed on January 5, 2019 from 7:00am to 9:30am.
3. Entry fee is \$ 25.00 per animal. There is no entry fee for showmanship.
4. Any exhibitor 21 years old or under is eligible to show.
Exhibitors must be old enough to show their own pig.
5. Health Papers are required on all hogs entering the Fairgrounds.
Health Papers will be checked before pigs are unloaded.
6. Exhibitor can enter 2 animals in this show.
7. **Pigs will be penned - two pigs per pen.** You are encouraged to bring pen dividers.
Pens at the Jeff Davis show barn are 4' x 6'.
8. **Pens will be assigned as Entry Forms are received. If the barn fills up, you will have to show off your trailer!!!! If you want to show off of your trailer please indicate that on your entry form.**
9. All pigs must have an ear tag.
10. Entry forms must be completed and signed by the exhibitor, parent, and County Agent or Ag Teacher and posted marked by December 13, 2019 with entry fees. Late fee is \$10.00 per animal.
11. There will be 3 placing's per class (weight classes and showmanship classes).
Money will be given out according to number of head in class.
12. After hogs are weighed in at the show they will be classified according to weights. Classes will be broken with as even number of entries as possible.
13. There will be no reweighs once the hogs leave the scale area. **All exhibitors questioning weights must voice concerns at the time the weight is announced.**

14. Each exhibitor must show the animal that was tagged, weighed, and entered in his/her name. A substitute driver may be used only if approved by the FFA Livestock Committee.
15. Each hog will be assigned to a weight class. The FFA LIVESTOCK COMMITTEE will determine the number of classes.
16. Show order will be as follows:
 - a. 5 Showmanship Classes (Oldest to youngest)
Grades 10-12, 7-9, 4-6, 1-3 and K & Under
 - b. Barrows (Lightest to Heaviest)
 - c. Gilts (Lightest to Heaviest)
17. All hogs will be shown at the owner's risk.
18. The first place hog from each class will be judged for Grand Champion. The second place hog from the Champion's class will be judged with first place hogs for Reserve Champion.
19. All premiums and prize money are contingent upon the availability of funds.
20. Any contribution to the show must be made through the Jeff Davis FFA.
21. The Jeff Davis County 4-H, Jeff Davis County FFA, Jeff Davis County Livestock Association and the Jeff Davis County Fair Association and any of its members are not liable for accidents, injury or theft.
22. Each exhibitor must assume all risk for his or her animal.
23. The FFA Livestock Show Committee will decide upon points not covered in the above said rules.
24. The Jeff Davis County FFA Livestock Committee reserves the right to interpret the rules. Decisions of the Judge and Livestock Committee will be final.
25. Criticizing or interfering with the judge, exhibitors, classifiers, grievance committees, weigh committees and other show officials or other conduct detrimental to the show will result in automatic disqualification from this show and future shows.
