

Hart EMC Pig Classic

1. Georgia exhibitors that are 21 years old or younger are eligible to show.
2. All entries must be able to provide an accurate, up to date health certificate that has been issued by a licensed veterinarian.
3. **Each pig entered must have a clean, readable state ear tag in place.** No pigs will be accepted without an ear tag.
4. There will be a purebred division for Duroc, Hampshire, Yorkshire, Berkshire, and AOB breeding and market hogs. **Must have 5 entries of the same breed to create a class. All purebred entries will require the appropriate registration number/paperwork at check-in.** If unable to provide registration information, pigs will be shown as crossbreds. Purebred champions will return for the grand drive following the conclusion of the crossbred division
5. Purebred Breeding Gilts must have a **All purebred entries will require the appropriate registration number/paperwork at check-in. Must have 5 entries of the same breed to create a class.**
6. **For the market show. Barrows and gilts will be shown together. Boars are not eligible to show.**
7. Purebred Breeding Gilts are **Maximum Weight is 375 lbs.**
8. The Crossbred division will consist of all crossbred and non-registered market hogs.
9. All market hogs will be shown by weight. **Maximum weight is 280 pounds.**
10. Showmanship will be broken into grade ranges following check-in. Showmanship will begin at 8AM on Saturday morning, starting with the youngest division.
11. Class premiums/payout will depend on the amount of entries received.
12. Due to limited pen space, **entries will be limited to the first 250 received.** 4'x6' pens will be assigned for all entries, with the exception of those that paid to show off of their trailer. **If an exhibitor has multiple entries, please plan to pen two pigs together.** No tack pens will be provided. Trailer space is limited and will be accepted on a first come, first serve basis.
13. Check-in will take place from 4-8PM on Friday, January 10th. A pig's weight will be considered final once it leaves the scale.
14. Once pig is checked in it may not leave the property.
15. The judge's decision in each class is final and may not be challenged.
16. Exhibitors are responsible for their own animals and assume all associated risk.
17. All entries must be postmarked by December 10th, 2024. The entry fee is \$30.00 per market hog, and \$10.00 for showmanship. A late fee of \$35.00 per head, and \$15 for showmanship will be required after December 15th and must be paid prior to completing check-in. **The show committee reserves the right to refund money if the number of entries exceeds the show's capacity.** All entries should be mailed to **Chase Greene, 6570 GA HWY 145 Carnesville, GA 30521.**
18. **No alcoholic beverages are allowed on school grounds before, during, or after the show.**
19. No camping on school grounds.
20. No Firearms on school grounds
