- Any registration entry or fees received after October 30 will incur an additional \$5 entry fee/person.
- The top ten (10) individuals in each age division will receive certificates. Additional prizes will be awarded to the top three (3) individuals and the top three (3) teams in each age division.
- Contest classes will be based on availability of livestock with up to eight (8) classes including market and/or breeding classes in beef, swine, sheep and/or goats. Performance data may be provided on breeding classes.
- Classes and designated reasons and questions classes will be announced at orientation.
- Contestants will be allowed fifteen (15) minutes to evaluate each class, make observations, take notes and fill out placings cards.
- Senior division participants will give two (2) sets of oral reasons. Junior division participants will give one (1) set of oral reasons. Two (2) minutes will be allowed to give oral reasons on each class.
- Junior division participants will have one (1) questions class.
- Members of the Officials committee will offer critique following reasons.
- Results and awards ceremony will follow the committee's critique.
- Contestants talking to anyone other than a group leader during the contest will be disqualified. Personal communication devices are prohibited.
